Dear Committee Member,

We have had an enquiry from the State of Illinois about their use of ALTA Registry detailed data as part of their licensing activities. They have indicated that they are considering adding a field to their licensing database for the ALTA ID and may also require it as part of the licensing process. They also want to use the data as an additional data point to drive accuracy of their own information. The enquiry was made within the last 5 days and it would appear that their IT staff is at crucial stage of programming where adding the ALTA ID to their database is straight forward.

ALTA Staff and Co-Chairs have met to discuss this opportunity and given the tight timeframe created by the holidays, the new year, and the proximity of the next Board of Governors meeting, we have decided move forward with the creation of a proposal to the BoG, to allow a government entity to obtain a subscription to the ALTA Registry for detailed records.
